



# GatorMade Trailer Warranty Information

## TRAILER WARRANTY

GatorMade would like to thank you for purchasing what we consider to be the finest trailer available. The truck trailer described herein has been manufactured in accordance with the highest standards and specifications of GatorMade, 2400 N Hwy 27, Somerset, KY 42503. (Hereinafter referred to as "GATORMADE")

For the benefit of the first end user of the trailer (hereinafter referred to as "the original purchaser") GATORMADE has established the following warranty program to be administered on its behalf by its authorized agents.

## WARRANTY PERIOD

The warranty applies to defects in materials and workmanship relating to construction, assembly and installation only and shall be effective for the following periods commencing after delivery to the original purchaser:

Electrical Wiring of Brakes & Lights	No warranty coverage
Paint Chipping	No warranty coverage
Brake Drums, Pads and Hardware	100 % first 3 months
Hub Caps	100 % first 3 months
Grease & Oil Seals	100 % first 3 months
TIRES	Warranty handled directly by the customer with tire manufacturer.

## **COVERAGE & LIMITATIONS**

If authorized in accordance with the warranty period as it appears, preceding, parts that are determined on examination by GATORMADE to have been defective in material or workmanship under normal use, maintenance and service, carrying legal loads not in excess of the manufacturer's rated capacity on well maintained public roads, shall be repaired or replaced at GATORMADE's discretion, by GATORMADE at its plant or by an authorized selling distributor. Parts claimed to be defective in material or workmanship must be brought to the attention of and returned to GATORMADE and/or the authorized selling distributor by written notification within 10 days of discovery, and any repairs or replacements must be scheduled within 30 days thereafter.

It is agreed and understood that, except for the above warranty, no other warranty, expressed or implied or statutory, is made by GATORMADE or its selling distributors, and that they do not make any implied warranty of fitness. The aforementioned warranty is null and void on any trailer that has been modified from original sale form. This will be determined by a GATORMADE representative and any decision made will be final and uncontestable.

Warranties of merchantability, or of fitness for a particular purpose, or arising from a course of dealing or usage of trade are specifically excluded. Any statement made by GATORMADE or its selling distributors in the sale of the product shall not create any warranty that the product shall be fit for any particular purpose. Statements or descriptions are informational only, and not made or given as a warranty in any way.

All repairs and replacements are made and furnished subject to the same terms, conditions, warranty, disclaimer of warranty, and limitation of liability and remedy as apply to each new trailer sold.

This warranty shall not apply with respect to any claimed defect that in the judgment of GATORMADE has arisen from; owner misuse, negligence, or accident; owner operation at a speed exceeding State or Federal law; or from loading or operating beyond the rated load established by State or Federal law.

GATORMADE shall have no liability under any circumstances for loss of time, loss of use, inconvenience, loss of profits or income, damage to person or property, or for any other reason incidental, consequential or indirect damages resulting from a breach of any expressed or implied warranties, should such implied warranties be found to exist notwithstanding the disclaimer of such warranties contained herein.

The foregoing, shall be the original purchaser's sole and exclusive remedy, whether in contract, tort or otherwise, and GATORMADE and its agents shall in no way be liable for incidental or consequential damages or commercial loss or for damages to property or injuries to persons.

Neither GATORMADE nor any company or person affiliated with them makes any warranties, representations or promises, expressed or implied, as to the quality or performance of the product other than those set forth above.

This warranty is transferable to any new owner of the trailer still retaining the original time limits expressed by the aforementioned warranty periods from the original date of sale.

## **PROCEDURES FOR OBTAINING WARRANTY REPAIRS**

To validate your warranty, the original purchaser must sign the warranty certificate provided herewith, which will be completed and returned to GATORMADE by the authorized selling distributor within 10 days of sale.

If you have a problem with your GATORMADE trailer that is covered by the aforementioned warranty and warranty period, please contact your authorized GATORMADE distributor promptly to arrange for whatever repairs are warranted. Only GATORMADE Inc. or authorized distributors can perform warranty work.
